healing minds and bodies

While the overall perception is starting to change, a stigma still exists when it comes to behavioral health services. The term “behavioral health” encompasses both mental health and substance use disorder.

At MCH we believe that behavioral health services play an important role in the overall health of our patients. Monadnock Behavioral Health Services offers the following: counseling and treatment options for substance use disorders; therapeutic and medication assistance for mental health disorders (depression, anxiety, post traumatic stress disorder, schizophrenia, bipolarity, etc.); crisis prevention in the Emergency Department; and assistance obtaining basic needs such as food, heat, and transportation.

Monadnock Behavioral Health Services is staffed with two psychiatrists, one psychologist, four licensed social workers, and a 24/7 crisis team in the Emergency Department. A progressive, inclusive care model is used at MCH that involves Primary Care and Behavioral Health clinicians working together to provide patients full, immediate access to care. A dynamic, multidisciplinary team approach helps patients see behavioral health as part of their overall medical care. As a result of this effort, every primary care practice has an assigned social worker who is an important member of its team. This is a great way for patients to see a social worker in their primary care office rather than schedule a separate appointment. We’re pleased to say that our successful model has been used at other hospitals in the state to start similar programs.

No patient will ever be turned away at Monadnock Behavioral Health Services regardless of diagnosis or ability to pay. Our number one goal is to help every patient we can in the communities we serve.

cancer care close to home

“I struggled with any kind of medical procedure—even something as simple as an exam. Needless to say, that meant that I neglected my health for many years.”

After finally mustering the courage to see a doctor, Mary’s worst fears came to light. In December 2016, she was diagnosed with endometrial cancer, also known as uterine cancer.

Determined to fight with everything she had, Mary had her surgery performed at Dartmouth-Hitchcock Medical Center, and eight weeks later, started chemotherapy at Monadnock Community Hospital.

“It took only one visit to the Oncology and Infusion Therapy Center to give me the warm, welcoming,

and confident feelings that last to this day,” says Mary. “So many people have to travel long distances to get this kind of care.”

At MCH, Mary was under the care of hematology oncologist, Dr. Robert Pritchard.

“Dr. Pritchard is a wonderful doctor who always encouraged me to ask questions. He also has a great sense of humor, which is so welcome when you face these kinds of challenges.”

With her cancer now in remission, Mary looks back fondly on her experience at MCH.

“The compassion and professionalism of every single staff member was unailing. I’ve told friends and family that it was like swimming in an ocean of love. That may sound corny, but every single visit exceeded my expectations. To this day, when I drive into the parking lot at MCH, I get a big smile on my face.”

When it comes to supporting Monadnock Community Hospital, Peterborough resident JanCorinne MacLennan-Kennedy has been a guiding presence.

A longtime member of MCH's Legacy Circle and Parmelee Society, JanCorinne helped support the renovation of The Birthing Suite at MCH with an incredibly

generous gift. In addition to being one of our most ardent supporters, she is passionate about the outstanding medical care MCH provides to the community.

When JanCorinne began experiencing pain in her right shoulder, she immediately turned

shoulder to lean on

to Dr. W. Bradley White, a highly skilled and accomplished orthopaedic surgeon at Monadnock Orthopaedic Associates.

"I had the option of having my surgery elsewhere, but for me, the choice was easy," says JanCorinne. "I wanted to be at MCH with Dr. White doing the surgery."

After Dr. White successfully operated on JanCorinne's ailing shoulder, she worked with Lynne Maloney, PT, Director of Physical and Medical Rehabilitation, to help her return to full strength.

"Lynne is great at motivation and she is fun to be with, even if you are hurt," says JanCorinne. "I've had home physical therapy in the past, but prefer working with Lynne."

JanCorinne has been a patient at major medical centers in New York City and feels MCH is on par with the larger hospitals she's been to in the past.

"I've been getting all of my care at MCH for over 30 years. I can't imagine going to any other hospital and I hope I don't ever have to. I know everyone at MCH and I am treated so well. It's a very important part of my life."

Needless to say, the feeling is mutual.



caring for our community

In September 2018, MCH completed a Community Health Needs Assessment to identify and prioritize the healthcare needs of communities in the Hospital's service area.

Conducting focus groups with community members and local social and human

service agencies, it was determined that the top five greatest healthcare needs in MCH's Primary Service Area were:

- 1 **Behavioral Health Care** (early detection and treatment)
- 2 **Drug and Alcohol Misuse** (prevention and treatment)
- 3 **Access to Care for High-Need Populations** (homeless, disabled, seniors, etc.)
- 4 **Care Coordination** (within MCH and between provider organizations)
- 5 **Unique Populations** (youth-oriented health programs, affordable adult dental care, etc.)

While the Community Health Needs Assessment is required every three years by the Affordable Care Act and the State of New Hampshire, MCH is committed to creating and continuing programs and services that benefit the community.

A number of important programs have been created through the Community Health Needs Assessments including Monadnock Healthy Teeth, a school-based dental health program for children; Be the Change Behavioral Health Task Force, which provides community education regarding substance use and behavioral health; and the Healthcare Transitions Team, a group that addresses the care coordination between provider organizations in our community.

against all odds

Jaffrey resident Michael Mika is no stranger to adversity.

Born in Nazi-occupied Paris, Mike and his family survived the D-Day invasion in Normandy in 1944.

Years later, he disarmed a robbery suspect as a highly decorated New York City police detective. He was critically injured in a horrific car accident on Route 202

in Peterborough in 2015. And if that wasn't enough, a debilitating bout with Crohn's disease nearly cost him his life in 2016.

His latest challenge took place last summer.

"I woke up and couldn't move my left arm," says Mike. "I knew I was having a stroke."

As Mike was being rushed to MCH, first responders used Telestroke technology, a combination of video

conferencing and image sharing, to diagnose the severity of his stroke. Quickly and accurately diagnosing a stroke is essential to the long-term prognosis of the patient. Using this technology, MCH treated 18 stroke patients between July and December 2018.

Upon his arrival, Mike was treated by MCH neurologist Dr. Sachin Dave.

"Dr. Dave has made a tremendous difference in my life," says Mike. "He's personable and takes a lot of time with me. He has gone above and beyond in my opinion."

Despite everything he's gone through, Mike considers himself a lucky man.

"I've been to a lot of hospitals over the years, but MCH has been my mainstay. I'm so lucky the Hospital is as close as it is."

Samantha Krook knew something wasn't quite right. A few days after Thanksgiving, the 26-year-old New Ipswich resident noticed her feet and ankles were swelling and she was having difficulty breathing.

"I thought it was odd, so I reached out to Annette Brooks, Advanced Practice Registered Nurse at Monadnock Internal Medicine," says Samantha. "She ordered some tests, and I had an ultrasound

and CT scan, both of which came back normal. At this point, I had gained close to 15 pounds and the swelling had continued to get worse."

An echocardiogram was then ordered, which revealed a couple of abnormalities. Samantha was referred to

Dr. Jonathan Eddinger, a lipidologist at MCH, who diagnosed her with congestive heart failure.

"I'm not sure what I expected but this was definitely not it," says Samantha. "I was prescribed medication and a transesophageal echocardiogram was performed at Catholic Medical Center, which came back normal. As of right now, the cause of my condition is still a bit of a mystery, but I am so blessed to be healthy and so thankful for my doctors."

One thing that's not a mystery is how she feels about Monadnock Community Hospital.

"I would highly recommend MCH to anyone. I was blown away by my care here. I genuinely felt my health was important to each of my providers and getting me the help I needed was a priority."
